## 2018 Formulary Lists and Disruption Information

Together with CVS Caremark, our pharmacy benefit manager, we continuously monitor the marketplace and adjust our formularies to address rising drug trends. With these adjustments, drugs may move to a different tier or may no longer be covered. In addition, there may be changes to the prescription guideline requirements, including prior authorization, step therapy and quantity limits. Members who are negatively impacted by the formulary changes will be notified by letter about covered alternatives.

Formulary lists for 2018 are now available on [www.carefirst.com/rx](http://www.carefirst.com/rx) (ACA Small Group/Consumer Direct and 51+ Fully Insured) on the *Drug Search* page.

New and improved webpages have been developed to differentiate the 2017 and 2018 formularies and to provide a more seamless experience for our members. Members should continue to use their current 2017 formularies (i.e. Formulary 2) until they renew in 2018.

### Disruption Information for ACA Business

Member summary:

- Most members (approximately 75%) will not be impacted.
- Approximately 11% of members will be positively impacted because they are taking a drug that is moving down a tier.
- Approximately 13% of members will experience a negative disruption because their drug is being excluded, moving up a tier or has added utilization management criteria.


Impacted drugs summary:

- Over 91% of the drugs will not be impacted.
- Nearly 4% of the drugs will be positively impacted.
- Approximately 5% of the drugs will be negatively impacted.

Attached is an excel spreadsheet that lists the top 25 negatively impacted drugs for ACA disruption, which cover about 40% of the negative impacts. The table includes the drug name, drug class, change type (which negative action occurred with the drug), formulary alternatives, percentage of impacted members and the number of impacted drugs.
