

Each region has different requirements, so check with your account manager for more information.

<sup>4</sup> *National Committee for Quality Assurance's Health Insurance Plan Ratings for 2018-2019*; Kaiser Permanente has the highest rated commercial and Medicare plan (or is tied for the highest) in every geographic region we serve; nationwide, only 14 health plans received the highest possible rating (5.0 out of 5.0). Nine of those 14 are Kaiser Permanente health plans; for the third year in a row, Kaiser Permanente is the only health care organization in the country to have a health plan rate 5.0 for both its Medicare and commercial populations.
